Rhetoric Symposium Overview

The annual Symposium in Rhetoric has a long, prestigious history. For several decades we have brought to North Texas as keynote speakers many prominent rhetoricians, including Sonja K. Foss, Cynthia Selfe, Tim Crusius, Sharon Crowley, Don Bialostosky, Richard Enos, Susan Stanford Friedman, Jan Swearingen, Patricia Bizzell, Stephen Toulmin, James Kinneavy, Kenneth Burke, and Edward Corbett. This year we look forward to Dr. Brenda Brueggemann joining the list of distinguished speakers, adding Disability Studies to our growing understanding of rhetoric and all its possibilities.

Some Valuable Definitions:

RHETORIC: Rhetoric is the study of effective speaking and writing. And the art of persuasion. And many other things.

In its long and vigorous history rhetoric has enjoyed many definitions, accommodated differing purposes, and varied widely in what it included. And yet, for most of its history it has maintained its fundamental character as a discipline for training students 1) to perceive how language is at work orally and in writing, and 2) to become proficient in applying the resources of language in their own speaking and writing.

Rhetoric has sometimes lived down to its critics, but as set forth from antiquity, rhetoric was a comprehensive art just as much concerned with what one could say as how one might say it. Indeed, a basic premise for rhetoric is the indivisibility of means from meaning; how one says something conveys meaning as much as what one says. Rhetoric studies the effectiveness of language comprehensively, including its emotional impact (pathos), as much as its propositional content (logos). To see how language and thought worked together, however, it has first been necessary to artificially divide content and form.

KAIROS: The term kairos has a rich and varied history, but generally refers to the way a given context for communication both calls for and constrains one's speech. Thus, sensitive to kairos, a speaker or writer takes into account the contingencies of a given place and time, and considers the opportunities within this specific context for words to be effective and appropriate to that moment."
